7.	COUNTY COUNCILLOR'S REPORT - GT The Council budget is in the black at the moment but by year end it will be in the red. Council tax is to rise. The Council will remove its funding from various services but at the moment it is not stating what or where will be affected. County Councillor is concerned that the Leisure centre in Llanfyllin will be affected by the cuts as this is not a Statutory service. Post 16 Education is under review and at the moment the Sixth Forms in Welshpool and Llanfyllin are strong and work is being done collaboratively between Welshpool, Llanfyllin and Bro Caereinion. Recycling is a continual problem. This is a lean service and if for example a lorry driver is away there are no replacements which then creates a problem. It was commented that PCC are doing a route review for recycling – possibly with changes in the future for the routes. County Councillors had visited the recycling sites and these are being managed well. The Booking system online is working well but to make a booking via the telephone takes quite a while. Only 6 cars per 15minute booking are allowed. At the moment there is a review of the Recycling sites online – to register a complaint or issue use the online service.
